The event saw updates from our expert panel on the latest in DC decumulation, DB surplus release, pension dashboards and the impact of climate change on pensions, with a recording of the session now available on the SPP website.

Committee News

View All Committee Minutes

- 1. The Administration Committee discussed the Government response to the DB options consultation, surplus release, the Government's Pensions Roadmap and dashboards as well as their strategy day which they are holding in July, which will explore how their work can more neatly fit in with SPP's overall policy objectives to help regulators and policymakers deliver effective pensions policy, champion DC schemes and advocate for DB schemes.
- 2. The **DB** Committee debated how best to encourage collective schemes and agreed to establish a working group on the same, TPR's timing for scheme returns, surplus extraction, and the Government response to the DB options consultation.
- 3. The Risk Transfer Group was updated on progress from the recent Risk Transfer roundtable which focused on problems experienced by smaller organisations; talked about the superfund legislative regime, practicalities of surplus distribution and benefit simplification for risk transfer solutions.
- 4. The **Legislation Committee** discussed the likely content of the forthcoming Pensions Schemes Bill, the Government response to the DB options consultation; the final Investment review report, TPR response to the Statement of Strategy consultation, discussed pensions policy sequencing and the imminent pensions roadmap as well as being updated on a recent SPP/DWP meeting on Guided Retirement Products. There was also an update on HMRC's PTM on designation to drawdown.
- 5. The Covenant Committee discussed the Pension Schemes Bill, the Government response to the DB options consultation, Pensions Roadmap, the TPR response to the Statement of Strategy consultation and future covenant related SPP events.
- 6. The **DC** Committee noted the TPR/PPI report on UK retirement income market Pensions Bill, were updated on recent SPP/DWP discussions on Guided Retirement Products, noted the new Pensions Roadmap and then discussed the Pension Schemes Bill in depth.

Parliamentary & Stakeholder Engagement

SPP's Council had met with Pensions Minister Torsten Bell MP to talk about a range of issues from surplus release and productive finance to decumulation and adequacy.

We also met also Daisy Cooper MP, the deputy leader of the Liberal Democrats, as well as Steve Darling, the Liberal Democrats Shadow Secretary of State for Work & Pensions and John Milne, a Liberal Democrat member of the Work & Pensions Select Committee, to discuss the recently published Pension Schemes Bill. SPP also held a meeting with Reform MP James McMurdock to talk all things pensions.

Representatives from the Legislation and DB Committees met with the PPF to discuss PPF-related elements of the Pension Schemes Bill, while a covenant specialist from The Pensions Regulator attended the last Covenant Committee meeting. The quarterly Pensions Policy Group established by the SPP, comprising the PPI, PLSA, ABI, TISA and PMI, met to provide organisational updates on various pensions policy issues. SPP also met with DWP officials to discuss Guided Retirement Products – or default pension benefit solutions as they're now catchily titled.

Sophia Singleton's first anniversary as SPP President was marked with an article in <u>Professional Pensions</u>. Bina Mistry shed light on government plans for surplus release in <u>Pensions Expert</u>.

Our comments on Virgin Media were picked up by Professional Pensions and Pensions Expert.

Jon Forsyth, chair of SPP's DB committee, had his comments on a PPF Consolidator covered by <u>Pensions Expert</u>.

Mallowstreet quoted Deputy Investment Committee Chair Chris Austin in relation to the Spending Review.

Meanwhile, SPP polling on benefit simplification and "better of" tests was highlighted in both <u>Pensions Age</u> and <u>Actuarial Post</u>.
