#### **Professional Development Event**

This month saw SPP's latest Early Career Professionals event take place, with both a full room and more online hearing from a diverse panel of industry experts on how to build connections, confidence and balance early in pensions careers.

#### **Upcoming Events**

This month saw <u>both in-person and online bookings open</u> for the final Early Career Professionals event of the year, The Debates, on December 3rd. Kindly hosted at the London offices of Pinsent Masons, this session brings together industry experts to generate discussion on two key issues in pensions in an informal debate setting, with a live audience vote deciding the winner of each. This year's debate topics

- Should the default position be that pension scheme surpluses are returned to the scheme sponsor?
- Must Automatic Enrolment contributions be increased beyond the 8% minimum now?

Registrations are also open on a first-come, first-serve basis for SPP's first online roundtable session for Early Career Professionals on **Thursday 4<sup>th</sup> December between 12pm and 1.15pm**, providing an opportunity for Early Career Professionals to explore key DB and DC industry topics within a smaller group.

#### **Committee News**

**View All Committee Minutes** 

1. The Investment Committee had an engaging and well received guest speaker, Steve Lomas, Managing Director (Banking & Investments), National Wealth Fund who discussed the various means by which pension funds and the Fund could work together, and where that would be less appropriate. The Committee noted the issue of permitted links rules and its forthcoming meeting with the FCA to discuss this.

2. The **Legislation Committee** looked at the draft clauses on Virgin Media; draft legislation on IHT on pensions; draft legislation on registering tax advisers (which inadvertently captures pension professionals); were updated on the PPF levies (one abolished, one reduced to zero), examined the Third State Pension age review (now submitted). There were mixed reactions to the TPR consultation "a new approach to enforcement" and the Pensions UK Small Pots Feasibility Review was considered, including potential conflicts with the Pension Schemes Bill.

- 3. The **DC Committee** noted recent SPP thought leadership papers and consultation responses, before discussing the scale test for default common investment strategies. The Pensions UK Small Pots Feasibility Review was discussed, with broad agreement that imposing these additional responsibilities on industry would not be welcomed at this time.
- 4. The **DB Committee** discussed pre-1997 indexation, as a result of which SPP will be producing a short paper on the subject, due for publication in November.
- 5. The **Administration Committee** considered recent SPP correspondence to HMRC in relation to scheme returns; TPR's new market oversight report; the concept of an SPP pensions roadmap building on that released by government earlier this year; The Pensions UK Small Pots Feasibility Review was explored, noting the resource implication and administrative complexity, which would pose barriers.

## Parliamentary & Stakeholder Engagement

SPP engaged with MPs and Peers including Baroness Cash (ESG & Investments) Sir Stephen Timms MP and Marsha de Cordova (SPP's Ethnicity paper) as well as Conservative MP Peter Bedford in relation to the forthcoming Budget.

We also sent all MPs and Peers our response to the DWP review of the State Pension Age, as well as our DEI papers on ethnicity and gender.

#### **SPP** in the News

SPP's media coverage this month included our polling on ESG and pensions being covered by <u>Actuarial</u> <u>Post</u>, <u>Professional Pensions</u>, <u>Pensions Age</u>, <u>Corporate Adviser</u>, <u>Business Green</u> and <u>Environmental Journal</u>.

SPP's September call for pension professionals to be exempted from HMRC plans for tax advisers to register with them was again highlighted in <u>Professional Pensions</u>.

Our submission to the House of Lords on IHT also secured coverage in <u>Actuarial Post</u>, <u>PensionsAge</u> (twice), <u>Professional Pensions</u> (twice), <u>Wealth Investment News</u> and <u>Corporate Adviser</u>.

SPP's August paper on neurodiversity was referenced on several occasions by <u>Benefits Expert</u> and SPP's September Inclusive Futures paper on disability featured in <u>FT Adviser</u>. Our Inclusive Futures paper on ethnicity published in October featured in <u>PensionsAge</u>, <u>Benefits Expert</u>, <u>HR News</u>, <u>Law360</u> and <u>Actuarial Post</u> and our Gender focused paper featured in <u>Actuarial Post</u> and <u>HR News</u>.

Our views on the government review of the State Pension Age were covered by <u>Actuarial Post</u>, <u>HR News PensionsAge</u> and <u>Pensions Expert</u>.

Adrian Bourne, Co-Chair of the SPP Covenant Committee wrote an informative piece about recent changes to the 'value at risk' measure for DB pension schemes in <u>Pensions Expert</u>.

The SPP generated 40 pieces of media coverage in October 2025.
