Committee News

View All Committee Minutes

1. The **Legislation Committee** considered the implications of Virgin Media, considered the dashboards programme and <u>recently announced plans</u> to deal with small pots.

2. The **DB Committee** discussed the issue of surplus extraction, including our conversations and correspondence with DWP on the issue; our scheme returns correspondence with TPR; the Government response to the Work & Pensions Committee report on DB schemes and the Annual Funding Statement.

3. The **Covenant Committee** talked about surplus extraction including SPP's conversations with DWP on both <u>Section 251</u> and <u>Covenant</u>; the <u>Annual Funding Statement</u> published by TPR last month; TPR's Superfund <u>blog</u> and updated on a recent call between TPR and Covenant Committee reps on surplus extraction.

4. The **DC Committee** discussed DWP plans for Guided Retirement Products; SPP's Adequacy paper due to be published this summer; recently announced plans to deal with small pots and the Mansion House Accord published on 13 May.

Parliamentary & Stakeholder Engagement

SPP sent all 650 MPs a copy of <u>our paper</u> on the impact of Trump's tariffs, our President participated in a roundtable on adequacy hosted by Conservative MP Peter Bedford and we engaged with a number of politicians from Baroness Lister (Labour) and Baroness Altman (Conservative) to Bob Blackman (Conservative) and Baroness Ritchie (Labour) on issues from Al and tariffs to adequacy.

Representatives from the Legislation and DB Committees met with the Pension Protection Fund to discuss a range of issues from surplus and dashboards to levy flexibility. Members of the DC Committee met with DWP officials to talk about government plans for Guided Retirement Products.

SPP in the News

SPP's <u>informational paper</u> on the impact of Trump's tariffs on UK pensions secured almost 30 pieces of media coverage. This included national media outlets <u>GB News</u>, <u>The Telegraph</u> (paper and online), <u>MSN</u>, <u>Yahoo Finance</u>, the <u>Daily Express</u> on three separate occasions, <u>Daily Mirror</u> and <u>Sky News</u> (television and online). It was also covered by the main pensions press, financial advice trade press and regional news outlets like the <u>Birmingham Mail</u> (twice) and the <u>Manchester Evening News</u> as well as being featured on <u>The Pensions Podcast</u>.

SPP DC Committee member Steve Charlton was quoted in <u>Pensions Age</u> and <u>Professional Pensions</u> in relation to the new Mansion House Accord.

Our polling of industry views on DB/DC underpins in risk transfer and consolidation was featured in <u>Pensions Age</u> and the SPP were referenced in relation to Virgin Media in <u>Professional Pensions</u>

James Sparshott of SPP's Public Sector Group, had an article on growth published in the <u>May edition of LAPF</u>; Lynn Housecroft had an article on the quiet revolution of Al in pensions published in <u>FinExtra</u>, whilst Matthew Swynnerton had an update on Virgin Media published in <u>Pensions Expert</u>.

This month's "View from the SPP" article was on Covenant and surplus and appeared on page 23 of <u>Pensions Age</u>. The same publication also featured Financial Services Regulation Committee Chair, Amanda Cooke's comments on FCA plans for "targeted support" (page 43).

SPP's industry polling on scheme surplus was covered in <u>IFA Magazine</u>, <u>PensionsAge</u> and <u>Professional</u> Pensions.

SPP's initial reaction to the Pensions Investment Review publication featured in <u>Actuarial Post</u>, <u>FT Adviser</u> and <u>Chief Investment Officer</u>, <u>PensionsAge</u>, <u>Pensions & Investment Europe</u> and our broad support was referenced in the national media - the <u>i newspaper</u> as well as being syndicated on <u>Yahoo Finance</u> and <u>MSN</u>.

Our initial reaction to the DB Options response was included in Professional Pensions.
